**Bioretec has applied for its shares to be listed on Nasdaq First North Growth Market Finland and commences the initial public offering**

Bioretec Ltd ("**Bioretec**" or the "**Company**") today announces that it has today submitted a listing application with Nasdaq Helsinki Ltd for listing of the Company's shares (the "**Shares**") on Nasdaq First North Growth Market Finland maintained by Nasdaq Helsinki Ltd ("**First North Growth Market**") under the trading code "BRETEC". Trading in the Shares on First North Growth Market is expected to commence on or about 18 June 2021.

Subject to the listing application of the Company being approved, Danske Bank A/S, Finland branch will act as Bioretec's certified adviser in accordance with the Nasdaq First North Growth Market Rulebook.
